
## Liability waivers, Carpool pick-up, and Photo release



1. A review of our insurance coverage has raised the issue of liability in the case of injury in the course of placing a child in a car. The ESNS Board lawyer has requested that you sign the following form.

If you do not wish to sign the form and thus do not wish to have the teachers open the car door to help your child into and out of the car, you can certainly be responsible for loading and unloading your child yourself. However, for the safety of all concerned, we do request that you join the carpool line and wait your turn to drop your child in the early morning or to fetch him/her at the end of the school day.

#### 2. COVID-19 Waiver and Release

- A. I acknowledge that federal and state government officials have declared that there currently exists a public health crisis in our country related to the Coronavirus Disease 2019 ("COVID-19").
- B. The safety and security of the children in its care remains the most important priority of ESNS. To help reduce the spread of COVID-19 and to protect ESNS employees and students, ESNS is adhering to all safety and health guidelines for the prevention of COVID-19, including those issued by the Missouri Department of Health and Senior Services, the St. Louis County Department of Public Health, and the Centers for Disease Control and Prevention. ESNS also strongly encourages all children and parents to adhere to all safety and health guidelines for the prevention of COVID-19, including engaging in frequent hand washing using soap and water for at least twenty seconds (or, if soap is not available, use an alcohol-based hand sanitizer), sanitize surfaces and objects frequently used, wear personal protective equipment such as face masks and gloves, and follow any and all other preventive measures recommended by applicable authorities.
- C. Notwithstanding the foregoing, I understand that the above guidelines do not completely eliminate my child's risk of exposure to COVID-19, and ESNS cannot guarantee that my child will not be exposed to or contract COVID-19.
- D. If my child experiences any COVID-19 related symptoms (such as fever, cough, body aches, or shortness of breath), I agree to keep my child home, not to bring my child to ESNS, and to follow the advice of my healthcare provider, clinic, or hospital. In such a case, I will immediately alert ESNS.
- E. I agree to follow the current ESNS mask guidelines, and I acknowledge that they are being continually evaluated and updated by the Board of Trustees and medical professionals within our community.
- F. I, the undersigned, agree to release, discharge, hold harmless and indemnify ESNS, its agents, employees, officers, Board of Directors, insurers and others acting on ESNS's behalf (the "Releasees"), of and from any and all claims, demands, causes of action and/or legal liabilities for injuries to or death of my child occurring during, or resulting from, or participation in the school program or activities and related in any way to COVID-19, even if the cause, damages or injuries are alleged to be the fault of or alleged to be caused by the negligence or carelessness of the Releasees.
